

## Demonstrators

- Vantage Trade Show Talent is the official IDDBA 2024 demonstrator provider.
  - Demonstrators hired through Vantage Trade Show Talent by an exhibitor to work in their booth may register at no charge when the exhibitor agrees to the demonstrator guidelines.
  - Demonstrators not hired through Vantage Trade Show Talent will be charged the standard registration fees (\$300-\$525).
  - Demonstrators must remain in their own booth. As a matter of safety and courtesy to others, demonstrators outside the exhibitor's space are not permitted. Such activities must be contained inside the contracted booth space.
  - Demonstrators must be properly and modestly clothed. Excessively revealing attire is prohibited.
  - To register demonstrators:
    1. Fill out the Vantage Trade Show Talent order form online at [www.models4tradeshows.com/events/iddba](http://www.models4tradeshows.com/events/iddba).
    2. Fill out the Demonstrator Staff Application form (next page) and return to IDDBA. E-mail the completed form to [exhibitorservices@iddba.org](mailto:exhibitorservices@iddba.org).
- Both** forms must be completed by May 24, 2024 or the demonstrator registration will be subject to full registration fees (\$300-\$525).
- **Demonstrators from Vantage Trade Show Talent will be registered at no charge when:**
    1. A completed, signed, and approved Demonstrator Staff Application form (subject to approval and limits), with a valid credit card guarantee of performance, is received and on file at IDDBA by May 24, 2024. See Demonstrator Staff Application for details.
    2. A time sheet and work contract are completed by Vantage Trade Show Talent.
  - No employee from the exhibiting company, family member of an attendee, or industry employee serving as a demonstrator will be allowed to register free of charge.
  - Once the Vantage Trade Show Talent contract and IDDBA Demonstrator Staff Application have been received at IDDBA, Vantage Trade Show Talent will assign a demonstrator staff person (closer to the show date). IDDBA will register that person and the exhibiting company will receive a copy of the demonstrator badge confirmation.
  - **Remember** - the use of demonstrators is a privilege and an exception to the rule. IDDBA reserves the right to determine at what point demonstrators constitute interference with others and to revoke a demonstrator staff's no charge admittance or remove them from the expo and/or limit the number of demonstrators permitted in one booth.
  - All demonstrators must be trained on proper food safety guidelines.

	All demonstrator staff must be registered and wearing an official IDDBA badge with their real name to be admitted to the expo hall. No one else will wear this badge.
	A copy of each demonstrator staff's contract must be submitted to Vantage Trade Show Talent (Vantage will forward to IDDBA, once received).
	No employee from the exhibiting company, family member, or industry employee may serve as a demonstrator registering at no charge.
	No demonstrator staff may remove any product, at any time, from the show.
	During breaks and unscheduled work time, the demonstrator will leave the expo area.
	The demonstrator staff will stay within the exhibitor's booth space only. The demonstrator will not walk the expo handing out samples and/or any materials.
	The exhibitor will relay, explain, and ensure compliance of the above rules to each demonstrator or forfeit full registration fees for each demonstrator registered.

I have read and understand the above regulations, and hereby certify that the demonstrator staff registered will meet all above conditions. Any unauthorized changes will result in the charging of full registration fees to the exhibiting company.
